HOUSING OPERATION: BEACON OFFERS A RANGE OF HOUSING AND SERVICES TO MEET THE NEEDS OF VULNERABLE MEMBERS OF OUR COMMUNITY. WE OPERATE 537 QUALITY AFFORDABLE HOMES FOR APPROXIMATELY 900 PEOPLE IN THE TWIN CITIES. THE SIGNIFICANT MAJORITY OF OUR HOUSING SERVES HOUSEHOLDS EARNING LESS THAN 30% OF THE OF THE COMMUNITY'S MEDIAN INCOME. OVER HALF OF BEACON'S HOUSING INCLUDES ON-SITE SUPPORTIVE SERVICES TO HELP YOUTH, SINGLE ADULTS, FAMILIES, AND SENIORS SUCCESSFULLY EXIT OR AVOID HOMELESSNESS. 86% OF FORMERLY HOMELESS TENANTS MAINTAINED STABLE HOUSING. BEACON EXPENSES RELATED TO HOUSING OPERATIONS WERE \$3,127,082 AND EXPENSES RELATED TO HOUSING SERVICES WERE \$1,086,189.
