WE OPERATE 498 QUALITY AFFORDABLE HOMES FOR APPROXIMATELY 800 PEOPLE IN THE TWIN CITIES. THE SIGNIFICANT MAJORITY OF OUR HOUSING SERVES HOUSEHOLDS EARNING LESS THAN 30% OF THE OF THE COMMUNITY'S MEDIAN INCOME. OVER HALF OF BEACON'S HOUSING INCLUDES ON-SITE SUPPORTIVE SERVICES TO HELP YOUTH, SINGLE ADULTS, FAMILIES, AND SENIORS SUCCESSFULLY EXIT OR AVOID HOMELESSNESS. 87% OF FORMERLY HOMELESS TENANTS MAINTAINED STABLE HOUSING.
