WE OPERATE 609 QUALITY AFFORDABLE HOMES FOR OVER 980 PEOPLE ACROSS THE TWIN CITIES METRO AREA. THE SIGNIFICANT MAJORITY OF OUR HOUSING SERVES HOUSEHOLDS EARNING LESS THAN 30 PERCENT OF THE COMMUNITY'S MEDIAN INCOME. OVER 60 PERCENT OF BEACON'S HOUSING INCLUDES ON-SITE SUPPORTIVE SERVICES TO HELP YOUTH, SINGLE ADULTS, FAMILIES, AND SENIORS SUCCESSFULLY EXIT OR AVOID HOMELESSNESS. 85 PERCENT OF FORMERLY HOMELESS TENANTS MAINTAINED STABLE HOUSING FOR AT LEAST ONE YEAR.
